GATEWAY TO GREATER CHINA MARKETS**

HONG KONG COMPANY REGISTRATION AT A SNAPSHOT

- 1 A LIMITED COMPANY IS THE MOST COMMONLY-USED COMPANY TYPE
- 2 ALL NEW COMPANIES MUST OBTAIN A BUSINESS REGISTRATION CERTIFICATE FROM THE INLAND REVENUE DEPARTMENT (IRD), WHICH ACTS AS HONG KONG TAX AUTHORITY, WITHIN 1 MONTH OF COMMENCING BUSINESS
- 3 100% FOREIGN CORPORATE SHAREHOLDING IS ALLOWED
- 4 MINIMUM NUMBER OF SHAREHOLDERS: 1 (ONE), MAX 50 (FIFTY)
- 5 NO MINIMUM PAID-UP CAPITAL (CAN BE HK\$1) OR LEGAL RESERVES REQUIRED
- 6 NO NATIONALITY OR RESIDENCE REQUIREMENTS FOR SHAREHOLDERS AND DIRECTORS WHO CAN BE INDIVIDUALS OF ANY NATIONALITY, DOMICILE, AND RESIDENCE
- 7 COMPANY SECRETARY MUST BE A HONG KONG RESIDENT
- 8 COMPANY IS HONG KONG RESIDENT ONCE REGISTERED IN HONG KONG
- 8 A FLAT 16.5% CORPORATE TAX (a disadvantage compared to corporate tax in Singapore)
- 8 NO VAT
- 9 ZERO TAX ON CAPITAL GAINS AND DIVIDENDS
- 10 HONG KONG DOES NOT OFFER TARGETED TAX INCENTIVES TO FOREIGN-OWNED COMPANIES AND FOREIGN INVESTORS (a disadvantage compared to tax incentives in Singapore)

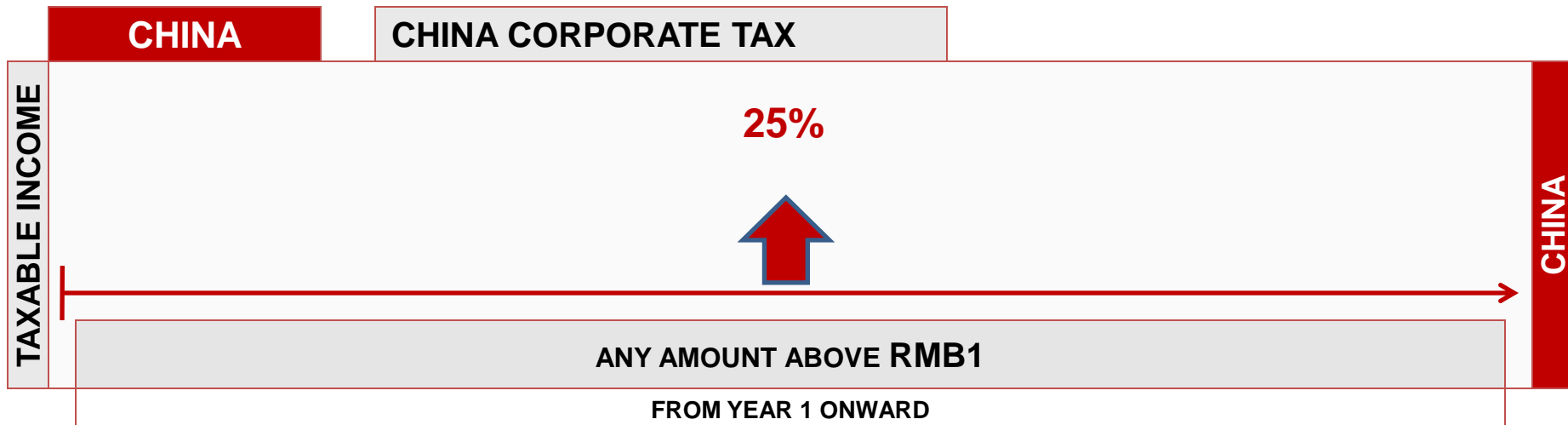

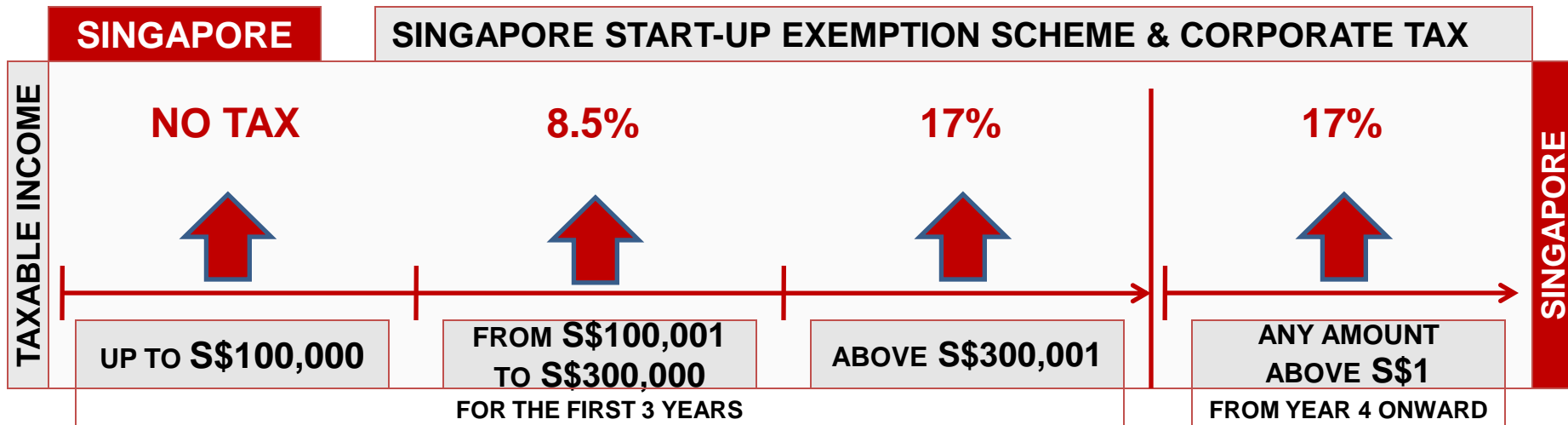

- ▶ a Hong Kong registered company must have a Company Secretary who must be a Hong Kong resident: our company will provide company secretarial service

NOMINEE DIRECTOR IN HONG KONG

Nominee Director in Hong Kong for 1 year

note:  according to company law the shareholder can be appointed as director, and both roles can be covered by individuals of any nationality, domicile, and residence. In case shareholder does not want to be appointed as director for confidentiality reasons, we can appoint a Nominee Director so that company can be actively operative.



In this case, the right to your company will be protected by Power Of Attorney certifying full management of the company by the shareholder while the Nominee Director will only represent the shareholder.



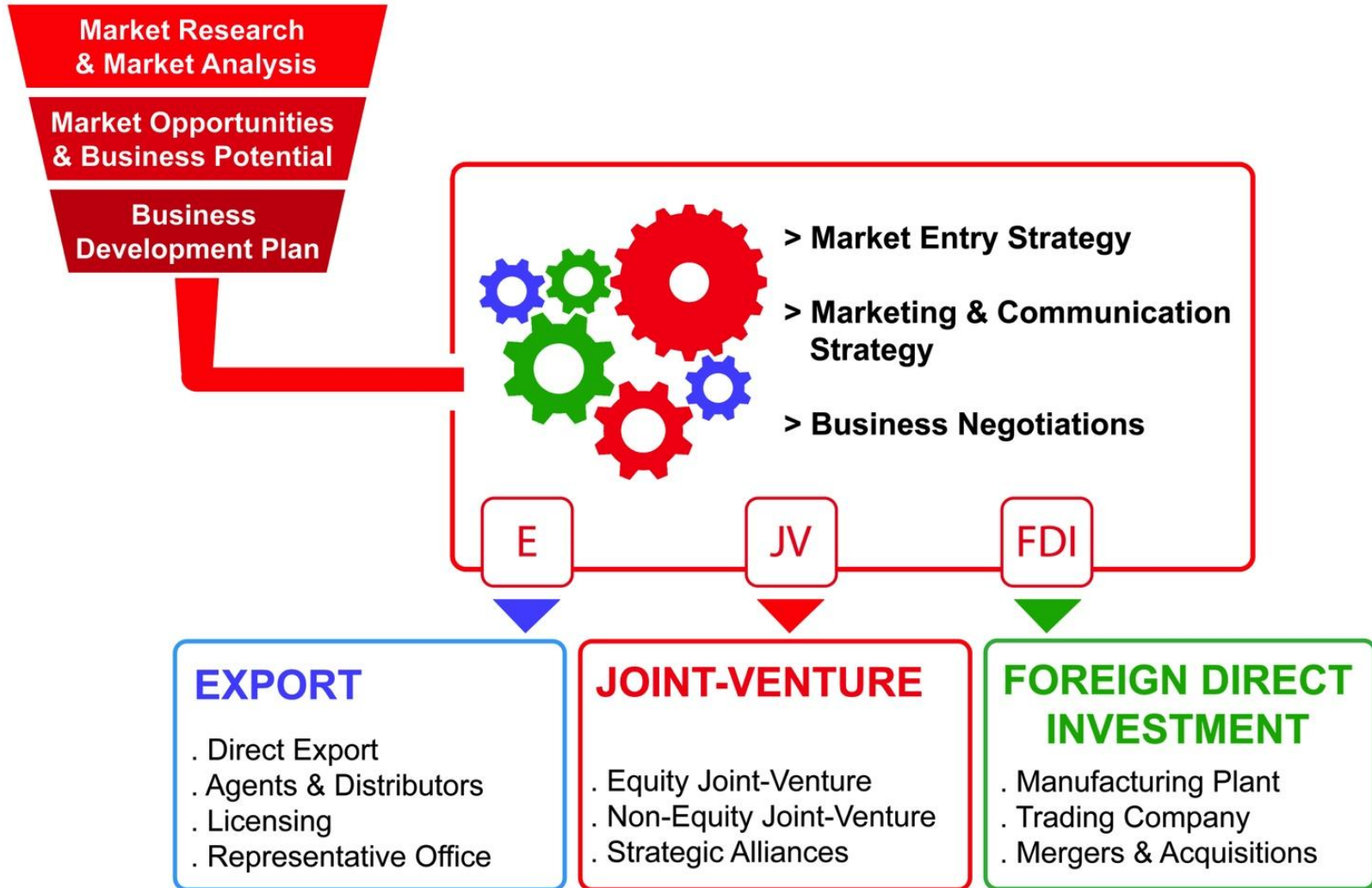
